3 Step Guide to Completing our Order form and the Chinese Consulate form

Step 1: Our Order form

- Please fill in your name on the form. Select your desired service and delivery option by ticking the appropriate box.
- Complete the delivery information, please ensure that this is correct and that all information, including a delivery contact number is present. If you have been referred to us by an Agency, please put this under “School and/or Agency” in the delivery section.
- You MUST inform us which province you are going to, otherwise our Guarantee won't apply.
- Finally, read through your terms and conditions, complete the payment information and sign the authorization.

Step 2: The Consulate Application Form

This is the step that sees us receive the most queries about.

It is actually quite simple to fill in once you know how. Most of the form is for our completion. This MUST be typed and MUST be double sided.

Section 1: Please complete with all of your information as requested. There should be no blank boxes, use N/A.

If you have received an offer from an employer, put that information where it says “name of employer”. Otherwise, put N/A.

For home address, please put where you currently reside, be that in the UK or not.

Section 2-7: These parts are precompleted. Ensure the ticks are relevant to your documents. Don't amend by hand.

Section 8: You must sign in two places.

Firstly, where it states: “signature of the Applicant”. Secondly, below this part, there is a declaration for you to read and sign once more underneath.

Please do not sign by the “Agent” part as this invalidates the form.

Step 3: Final Checklist

This is a list of all you need to send, please include all on the list otherwise it will delay your order:

1. Your UK Issued, Original Documents. We cannot Authenticate photocopies. You must send the original Degree, TEFL or Police Certificate that we are to Authenticate.
2. A Photocopy of your valid Passport. Please don't send us the original Passport. Ensure your passport is in date, matches the details on the Consulate form and that you have signed the original.
3. A proof of address, this can be a utility bill or bank statement.
4. Our China Authentication Order Form and a double sided, typed and signed Consulate Application Form, to be completed as laid out above

Once you have completed the above, post or courier your order to us.

Upon receipt of your package we will email you with confirmation that we have received your papers and are beginning the process.

We are unable to provide updates during this period and will only contact you if there is an issue with your order.
